In-class essay (5 minutes)

Explain the challenges of making the decision to evacuate prior to hurricane landfall,

1) from the perspective of a local government official issuing such an order:

Government officials can't evacuate too soon or too late. If the order is made too soon, evacuation shelters may not have had sufficient time to prepare, and local businesses would lose a lot of money. Further, people might not feel the storm's threat yet, and refuse to leave for days on end - meaning more people would stay and more post-storm rescue efforts would be required. On the other hand, if the order is too late, traffic could become congested and roads flooded, leaving people stranded in cars and homes. Hospitals and ambulances might not have to manpower to move large volumes of people in a very short time, and locals might not have enough time to prepare and thus choose to stay at home.

and 2) from your own personal perspective, following such an order:

I might have a job, and not want to be evacuated too early, since I need to go to work and make money. Further, I may have been evacuated unnecessarily last year, and feel like my government is merely crying wolf. If I am moving to a local shelter I probably will wait as long as possible, so as not to spend too much time in an uncomfortable environment. ALSO, I may not evacuate bcs I have a pet I don't want to move, or a person with limited mobility living in my household.

Explain the challenges of making the decision to evacuate prior to hurricane landfall,

Explain the challenges of making the decision to evacuate prior to hurricane landfall,

1) from the perspective of a local government official issuing such an order:

The local government wants to save lives. They would rather have people evacuated to safe locations than sitting in their potentially dangerous houses because 1) the people are less likely to get injured or die and 2) the govt won't have to try and rescue them in the middle of the storm and put more people in danger. Upon making the evacuation decision, the govt must consider traffic, the readiness of supplies and means of transportation, scientists, local business owners, ^{frized} museum artifacts, and local police and firefighters who will have to be standing by during the storm.

and 2) from your own personal perspective, following such an order:

As a private citizen, I am most comfortable in my own house. I may have pets or young children or elderly parents living with me and would rather not move them unless I am positive that I am in extreme danger. I likely consider how bad the previous storms were upon making my decision. I also would ^{ideally} ~~not~~ be away from my house for the shortest time possible.

Explain the challenges of making the decision to evacuate prior to hurricane landfall,

1) from the perspective of a local government official issuing such an order:

Government officials have a lot of responsibilities for protecting the local welfare and lives. While decisions must be made fast at times, they still require extensive planning and consideration. It would be in the best interest of the local government to receive as much feedback and information as possible from experts re: forecasting, possible property damage, high risk zones, business stakes, shelters, and citizens without means of transportation or support.

and 2) from your own personal perspective, following such an order:

Often times it is difficult to make a major decision like evacuating the house in a short period of time. Leaving the house requires difficult decisions about what to take and leave behind, where to go, who to go with, when to return, and who to contact to let them know of your departure. There are many concerns about leaving the house quickly, since hasty negligence can lead to further hazards like fire or theft. For some people, there is also an incling that (like Capt. MacWhirr in Conrad's Typhoon), there is no way of knowing the actual danger of the hurricane unless it is experienced.
